विश्वविद्यालय शिक्षकों के लिए भारत सरकार के पत्रांक No.-1-32/2006-UII/U(i) dated 21.12.2008 द्वारा 01.01.2006 के प्रभाव से लागू षष्ठम वेतन पुनरीक्षण आदेश में निहित अनुदेश के आलोक में राज्य के विश्वविद्यालयों में कार्यरत शिक्षकों को पी0एच0डी0 उपाधि के एवज में प्रोत्साहन भत्ता के रूप में अग्रिम वेतन वृद्धि अनुमान्य करने का मामला राज्य सरकार के विचाराधीन था।

2. सम्यक् समीक्षोपरांत राज्य सरकार द्वारा विश्वविद्यालय शिक्षकों के लिए भारत सरकार द्वारा 01.01.2006 के प्रभाव से लागू षष्ठम वेतन पुनरीक्षण संकल्प में निहित अनुदेश के आलोक में राज्य के विश्वविद्यालयों/अंगीभूत महाविद्यालयों में नियुक्त शिक्षकों को नियुक्ति के पूर्व प्राप्त की गई पी0एच0डी0 की उपाधि के एवज में 01.09.2008 के प्रभाव से प्रोत्साहन भत्ता (Incentive) के रूप में पाँच अग्रिम वेतन वृद्धि तथा सेवा काल में प्राप्त की गई पी0एच0डी0 की उपाधि के एवज में दिनांक 01.09.2008 के प्रभाव से प्रोत्साहन भत्ता (Incentive) के रूप में तीन अग्रिम वेतन वृद्धि अनुमान्य करने की स्वीकृति प्रदान करने का निर्णय लिया गया है।

3. यह अग्रिम वेतन वृद्धि सिर्फ उन्ही शिक्षकों को अनुमान्य होगा, जिन्होंने भारत सरकार के पत्रांक No.-1-32/2006-UII/U(i) dated 21.12.2008 में निहित निदेश के आलोक में पी0एच0डी0 की उपाधि पंजीकरण, कोर्सवर्क, मूल्यांकन आदि के लिए विहित प्रक्रियाओं आदि का पालन करते हुए ही किसी विश्वविद्यालय से प्राप्त किए हो। साथ ही उसी शिक्षक को यह अग्रिम वेतन वृद्धि देय होगी, जिन्होंने जिस discipline में Ph.D की उपाधि प्राप्त की हो तथा उसी discipline के शिक्षक के रूप में उनकी नियुक्ति हुई है।

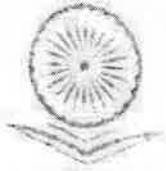
4. इस अग्रिम वेतन वृद्धि का लाभ विश्वविद्यालय शिक्षकों को बचम वेतन पुनरीक्षण के आलोक में दिया जा रहा है। अतः यह सिर्फ बचम वेतन पुनरीक्षण के लिए लागू अवधि में (01.01.2008 से 31.12.2018) सेवा काल में पी0एच0डी0 उपाधि प्राप्त शिक्षकों अथवा उक्त अवधि में सीधे नियुक्त शिक्षक जिन्होंने नियुक्ति पूर्व पी0एच0डी0 की उपाधि धारित की हो, उन्हें ही इसका लाभ देय होगा। वैसे शिक्षक जिन्होंने सेवाकाल में बचम वेतन पुनरीक्षण की अवधि के पूर्व अथवा उक्त अवधि के पश्चात् पी0एच0डी0 उपाधि धारित की हो, उन्हें इस अग्रिम वेतन वृद्धि का लाभ अनुमान्य नहीं होगा। ऐसे शिक्षक जो बचम वेतन पुनरीक्षण की तिथि के पूर्व सेवाकाल में पी0एच0डी0 उपाधि प्राप्त है, उन्हें विभागीय संकल्प संख्या 1669 दिनांक 18.05.2010 के तहत पंचम वेतन पुनरीक्षण के प्रावधानों के अनुरूप लाभ पूर्व में स्वीकृत किया जा चुका है।

5. प्रस्ताव पर मंत्रिपरिषद् की स्वीकृति प्राप्त है।

PUBLIC NOTICE

Sub: Clarification regarding admissibility of non-compounded advance increments and benefit of number of years required for promotion under CAS for the candidates who have enrolled/registered/completed Ph.D. degree before 11th July, 2009.

The University Grants Commission has been receiving a number of queries from the Universities with regard to admissibility of non-compounded advance increments as well as benefit of number of years required for promotion under CAS to such Ph.D. holders, who have enrolled/registered/completed Ph.D. degree before 11th July, 2009. The Commission at its meeting held on 14th November, 2018 considered the issue and approved that the non-compounded advance increments to such Ph.D. degree holders shall be admissible along with benefit of number of years required for promotion if the following conditions are met:

- Ph.D. degree of the candidate was awarded in regular mode only;
- Evaluation of the Ph.D. thesis by at least two external examiners;
- Open Ph.D. viva voce of the candidate had been conducted;
- Candidate has published two research papers from his/her Ph.D. work out of which at least one must be in a refereed journal;
- Candidate has made at least two presentations in conferences/seminars, based on his/her Ph.D. work

(a) to (e) above are to be certified by the Vice-Chancellor/Pro-Vice-Chancellor/Dean(Academic Affairs)/Dean(University instructions).

This may be brought to the notice of the colleges under your purview.
