On recommendation of the Bihar State University Service Commission, Patna as contained and communicated vide letter no. B.S.U.S.C./विज्ञान-56/2023 (खण्ड-10) 440 dated - 14.02.2025, the Vice-Chancellor has been pleased to appoint the following persons to the post of Assistant Professor in the subject of **SOCIOLOGY** in the pay scale of Rs. 57,700 – 1,82,400/- in the academic level – 10 (7th CPC) along with DA and other allowances as admissible by the State Government from time to time on the usual prescribed probation period with effect from the date of their joining.
